We want you to feel comfortable when booking a tour with Transcendent Travel, so we have a flexible Cancel for Any Reason policy up until 90 days prior to the tour departure date. This relaxed policy allows for ease of mind when planning your tour experience with us. Deposits and tour payments will not be refunded for any cancellations received by Transcendent less than ninety (90) days prior to the start of the tour.

RIGHT TO RESCHEDULE:

Should world conditions affect the staging of the tour (e.g., natural disasters, including, but not limited to, pandemics; war; terrorism), Transcendent Travel reserves the right to schedule the tour to a later date. In the event a tour participant is not willing to reschedule, and it is within 90 days of the tour start-date, all deposits and/or tour payments will be returned to such tour participant who has signed up, less any non-refundable expenses actually incurred by Transcendent.

COVID-19:

The health and safety of our customers is always our top priority. Each tour will have Covid-19 guidelines in place based on local requirements. As local ordinances are being updated regularly, we will share our policies closer to the tour start date. We reserve the right to update these on an ongoing basis per the available data and recommendations of local authorities. Before each tour, tour participants will be informed of the latest COVID-19 protocols in place and local destination laws. If borders are closed or we have any doubts about the health and safety of a destination and cannot operate a tour, we will give you first notice on a later set of dates. Any refunds will be determined in accordance with our Worry-Free Travel and Right-To-Reschedule Policies noted above. Every guest attending this tour must be fully vaccinated against COVID-19. Fully vaccinated means two (or equivalent) shots plus a booster. Guests will be required to carry proof of full vaccination at all times, and will be required to show proof at various hotels and tour destinations.

TOUR GUIDE:

Should the original tour director be unable to lead the tour on behalf of Transcendent Travel, Transcendent reserves the right to engage another competent tour director to lead and execute the tour.

SUBSTITUTIONS:

Transcendent recognizes that circumstances occur where it may be necessary to cancel participation in the tour. Substitutions are encouraged so that cancellation fees can be avoided. For substitutions made within 30 days of a tour date, an additional substitution fee of \$400 will apply.

Medical Insurance via Transcendent covers the following:

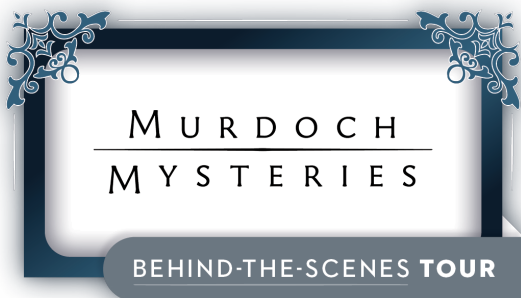
